#### **RESOLUTION 2013-31**

A RESOLUTION APPROVING AND AUTHORIZING THE DISANNEXATION OF CERTAIN LAND WITHIN WAYNE TOWNSHIP AND THE ACCEPTANCE OF THE LAND BY THE TOWN OF SPEEDWAY, INDIANA

WHEREAS, the Town Council of the Town of Speedway, Indiana (the "Town Council") is the legislative body of Town of Speedway (the "Town"); and

WHEREAS, Indianapolis City-County Council (the "City-County Council") is the legislative body of the City of Indianapolis and Marion County (the "City"); and

WHEREAS, the Petitioner has petitioned the City-County Council to adopt a resolution approving the petition for disannexation of the territory containing such land (the "Territory"), and a copy of said petition is attached as Exhibit A hereto; and

WHEREAS, the Petition also requires the approval of the Town Council and the acceptance of the land by the Town of Speedway; and

WHEREAS, the Town Council desires to designate, and from time to time refer to, the Territory as the "Speedway Annexation Area," which Speedway Annexation Area is more fully described on Exhibit B to this Resolution,

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SPEEDWAY, INDIANA:

- **SECTION 1.** Pursuant to IC 36-3-2-7, the Town Council hereby approves the Petition.
- **SECTION 2**. Both the City-County Council and the Town Council have approved their respective versions of this Resolution and has approved the disannexation and the annexation of the Territory.
- **SECTION 3.** The sections, paragraphs, sentences, clauses and phrases of this Resolution are separable, and if any section, paragraph, sentence, clause or phrase of this Resolution shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining sections, paragraphs, sentences, clause and phrases of this Resolution.
- **SECTION 4.** This Resolution shall be in full force and effect upon adoption and compliance with 1.C. 36-3-4-14 and IC 36-3-2-7.

The sections, paragraphs, sentences, clauses and phrases of this Resolution are separable, and if any section, paragraph, sentence, clause or phrase of this Resolution shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining sections, paragraphs, sentences, clause and phrases of this Resolution.

## PETITION FOR DISANNEXATION FROM THE CITY OF INDIANAPOLIS

The undersigned, Crawfordsville Road Partners, LLC, respectfully petitions the City-County Council of the City of Indianapolis, Marion County, Indiana, as the duly elected legislative body of the City of Indianapolis, to disannex pursuant to applicable law, from the City of Indianapolis, Marion County, Indiana, certain real property and in support thereof, respectfully states as follows:

- 1. WHEREFORE, the Petitioner specifically petitions as follows:

- 1. The City-County Council of the City of Indianapolis and Marion County approve this Petition for Disannexation and transfer of the Disannexation Territory to the municipal corporate boundaries of the Town of Speedway.
- 2. The City-County Council of the City of Indianapolis file a copy of the approval of this Petition, including the legal description of the Disannexation Territory, with the office of the Indiana Secretary of State and the Clerk of the Marion County Circuit Court.
