## **RESOLUTION NO. 2016-05**

A RESOLUTION OF THE TOWN COUNCIL OF SPEEDWAY, INDIANA APPROVING THE TRANSFER OF USED POLICE VEHICLES AND EQUIPMENT TO THE MARION COUNTY SHERIFF'S DEPARTMENT

WHEREAS, the Town of Speedway, Indiana (the "Town") has a fleet of police vehicles fully equipped for police service; and

WHEREAS, certain police vehicles and equipment has been determined to be surplus personal property by the Town's Chief of Police; and

WHEREAS, the Marion County Sheriff's office desires to transfer the surplus personal property to the use of the Marion County Sheriff's Department for service in Marion County; and

WHEREAS, IC 36-1-11-8 provides for the exchange of surplus personal property between units of government upon terms and conditions agreed upon by the entities; and

WHEREAS, the surplus property set forth in <u>Exhibit A</u> has been determined to be of value to the Marion County Sheriff's office and both governmental departments desire to transfer the property as set forth in <u>Exhibit A</u>.

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Speedway, Indiana that:

Section I. The property identified in Exhibit A has been designated surplus personal property and the Town Council hereby approves.

Section II. The Town Council hereby approves the transfer of the surplus property to the Marion County Sheriff's Department pursuant to the terms set forth in Exhibit A.

Section III. The Town Manager and President of the Town Council are hereby authorized to execute all bills of sale, titles or other documents necessary to effect the transfer of the surplus property to the Marion County Sheriff's office as set forth herein.

<u>Section IV</u>. This Resolution shall be effective upon adoption.
