A PUBLIC HEARING OPENED AT 7:01 PM FOR ORDINANCE 1318 ON SECOND READING. THE ORDINANCE IS THE 2020 BUDGET FOR THE CIVIL TOWN OF SPEEDWAY.

No comments given and the Public Hearing was closed at 7:01 PM.

Councilor Raikes made a motion to approve Ordinance 1318 on Second Reading, which received a second by Councilor DeLisle. There was no public comment or questions. The motion was approved by a vote of five to zero.

A PUBLIC HEARING OPENED AT 7:06 PM FOR ORDINANCE 1319 ON SECOND READING. THE ORDINANCE IS THE 2020 BUDGET FOR THE SPEEDWAY SCHOOLS.


