- 2. The Minutes of the March 11, 2024, Town Council meeting were approved as presented.
- 3. SPECIAL EVENT REQUEST FOR AMATEUR RADIO FIELD DAY

Jeff Hammer with Indianapolis Radio Club presented details regarding the event request. Councilor Sturgeon made a motion to approve the event request, which received a second from Councilor Harrold. A vote was taken, and the event request was approved five to zero.

4. REQUEST FOR TEMPORARY PARTIAL ROAD CLOSURE OF 14<sup>TH</sup> STREET FOR THE POCKET PARK GRAND OPENING

#### ORDINANCE No. 1388

# AN ORDINANCE ESTABLISHING A DESIGNATED OUTDOOR REFRESHMENT AREA WITHIN THE TOWN OF SPEEDWAY, INDIANA

**WHEREAS**, I.C. §7.1-3-31 authorizes the establishment of a Designated Outdoor Refreshment Area;

**WHEREAS**, the Town Council of the Town of Speedway, Indiana ("Town Council") believes it is in the best interests of the Town of Speedway ("Town") to create a Designated Outdoor Refreshment Area ("Refreshment Area") in the Town's Main Street area, as authorized by I.C. §7.1-3-1 *et seq.*, which Refreshment Area is shown on the map marked as Exhibit A attached hereto and incorporated herein.

**THEREFORE, IT IS ORDAINED** by the Town Council of the Town of Speedway as follows:

- 1. All definitions in I.C. §7.1-3-31 et seq. shall apply to this Ordinance;
- 2. The Town Council hereby adopts the map of the Speedway Main Street Designated Outdoor Refreshment Area attached hereto as Exhibit A and incorporated herein by reference;
- 3. The Speedway Main Street Designated Outdoor Refreshment Area boundary by streets is as follows:

#### (INSERT REFRESHMENT AREA BOUNDARY BY STREETS)

- 4. The Town Council finds that the Speedway Main Street Designated Outdoor Refreshment Area is consistent with the Town of Speedway's Zoning Code;
- 5. The Town Council hereby approves and adopts the minimum signage designating the Speedway Downtown Designated Outdoor Refreshment Area attached hereto as Exhibit B and incorporated herein by reference and directs the Town to place the signage at the designated locations on Exhibit C;
- 6. The Town Council recognizes that additional signage designating the Speedway Main Street Designated Outdoor Refreshment Area may be warranted and necessary, that Exhibits B and C are only minimum standards, and therefore, the Town of Speedway Street Department is hereby authorized and granted full authority to increase the number or change the type of signage in their sole discretion and in compliance with I.C. § 7.1-3-31;
- 7. The Speedway Main Street Designated Outdoor Refreshment Area shall be in effect during all authorized times pursuant to I.C. §7.1-3-1-14 as amended from time to time by the Indiana General Assembly;

8. The following retailer permittees, whose locations are identified on Exhibit A, have submitted a completed application to the Town to participate in the Refreshment Area as a Designated Permittee and the Town finds that each of them is an appropriate Designated Permittee and requests that the Indiana Alcohol and Tobacco Commission issue a Refreshment Area Designation to the following:



Any additional licensed premises located within the Speedway Main Street Designated Outdoor Refreshment Area who desires to be designated as a Designated Permittee and granted a Refreshment Area Designation shall submit an application, consisting of a completed State Form 57288 Designated Outdoor Refreshment Area Designation Form attached hereto as Exhibit D and incorporated herein, to the Town for approval and recommendation by the Town Council by Resolution;

- 9. Any establishments that desire to be a vendor for an event or festival held within the Speedway Main Street Designated Outdoor Refreshment Area shall submit an application, consisting of a Special Event Permit Application and State Form 57288 Designated Outdoor Refreshment Area Designation Form, to the Town for approval by the Town Council by Resolution:
- 10. A vendor's location may be at any area within the Speedway Main Street Designated Outdoor Refreshment Area as shown on Exhibit A, subject to approval of the Special Event Permit and State Form 57288 Designated Outdoor Refreshment Area Designation Form by the Town Council;
- 11. Nothing in this Ordinance prohibits a business, landlord or other establishment from prohibiting open containers of alcoholic beverages to enter their premises or from prohibiting alcoholic beverages purchased from another establishment to enter their premises;
- 12. The Town maintains full authority and control over the sidewalks, streets and public common areas and no one may prohibit or limit open containers in accordance with I.C. §7.1-3-31 *et seq.* within the Speedway Downtown Designated Outdoor Refreshment Area in those spaces except for the Town of Speedway Police Department;
- 13. In accordance with I.C. §7.1-3-31 *et seq.*, a person may consume an alcoholic beverage purchased from a Designated Permittee or vendor anywhere within the Refreshment Area boundaries, subject to the right of any retailer permittee or business within the Refreshment Area to refuse to allow individuals to enter the licensed premises or business with an alcoholic beverage;
- 14. In accordance with I.C. §7.1-3-31 et seq., all Designated Permittees and vendors may allow a person to exit the Designated Permittee's or vendor's licensed premises with not more than two (2) open containers of an alcoholic beverage at a time. The open containers must be in a

plastic cup no larger than sixteen (16) ounces. The contents of an open container may not exceed the following:

- a. Beer or flavored malt beverage of not more than sixteen (16) ounces.
- b. Wine, cider or hard seltzer of not more than twelve (12) ounces.
- c. A mixed drink of not more than ten (10) ounces containing not more than two (2) ounces of liquor.
- 15. A sign, as required by I.C. §7.1-3-31-16 and attached hereto as Exhibit E, must be posted at each exit of a Designated Permittee and on the licensed premises of a vendor;
- 16. Glass containers may only be allowed in a Designated Permittee's outdoor dining area and may not be removed into the Speedway Downtown Designated Outdoor Refreshment Area;
- 17. The Speedway Main Street Designated Outdoor Refreshment Area shall be in effect upon passage until October 31, 2024, and each year thereafter from April 1 through October 31.
- 18. This Ordinance shall be in full force and effect upon its passage and subject to the approval of the Indiana Alcohol and Tobacco Commission.



#### TAXPAYER OBLIGATIONS AGREEMENT AND GRANT OF REAL PROPERTY TAX LIEN

This Taxpayer Obligations Agreement (the "Agreement"), executed by and between HG Rebar Speedway 2500, LLC, an Indiana limited liability company (the "Rebar"); RI Speedway, LLC (the "Hotel"), and the Town of Speedway Redevelopment Commission (the "SRC") as of \_\_\_\_\_\_\_ (the "Effective Date").

#### Recitals

WHEREAS, Rebar is the developer of Founders Square as described in the Secondary Plat recorded on with the Marion County Recorder with recordation number and as otherwise attached hereto as Exhibit A and made a part hereof (the "Development"), subject to the terms and conditions of the EDA (as hereinafter defined); and

WHEREAS, pursuant to the EDA and related ancillary documents, the SRC and/or the Town issued one or more series of taxable economic development revenue bonds or bond anticipation notices (the "Bond"), which Bond has been made available to Rebar to pay for a portion of the cost of public infrastructure serving the Development; and,

WHEREAS, Pursuant to the EDA, Rebar agreed to make certain improvements to the Development; and

WHEREAS, SRC is relying on real estate tax payments from the Development to satisfy debt service on the Bond;

WHEREAS, pursuant to Paragraph 4.01 Assessments of the EDA, Rebar agreed that, during the effective term of the Bond and for two (2) years thereafter, Rebar, and any subsequent owners or tenants, shall not (a) apply for tax exempt status or (b) appeal a tax assessment for the real or personal property if the assessed valuation is within ten percent (10%) of the prior year's assessment after development and that Rebar shall have all subsequent owners and all tenants agree to be bound by the same (the "Tax Agreement"); and

WHEREAS, the hotel project Site is identified as Lot 11 and Block A of the Development ("Hotel Project Site");

WHEREAS, the Hotel is purchasing or has purchased the Hotel Project Site from Rebar and is therefore, a successor owner of Rebar and will benefit from the Development;

WHEREAS, Rebar, Hotel and the SRC have agreed to amend the Tax Agreement as it applies to the Hotel Project Site *only* and desire to enter into this Agreement;

#### Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged hereby, Rebar, Hotel and the SRC agree as follows:

#### 1. Defined Terms.

Applicable Rate shall mean the tax rate as is used for purposes of determining the Real Estate Taxes.

**Assessed Value** shall mean the value of all or a portion of the Hotel Project Site as assessed by the Taxing Authorities for the purpose of determining Real Estate Taxes.

**Bonds** shall mean those certain Town of Speedway, Indiana Taxable Economic Development Revenue Bonds, Series 2020.

Town shall mean the Town of Speedway, Indiana.

Commencement Date shall mean

Cure Period shall mean a period of 30 days after Hotel receives notice specifying the nature of a failure by Hotel to observe or perform any term or condition of this Agreement to be observed or performed by it; provided that, if the failure is of such a nature that it cannot be remedied within 30 days, despite reasonably diligent efforts, then the 30 day period shall be extended as reasonably may be necessary for Hotel to remedy the failure, so long as Hotel: (a) commences to remedy the failure within the 30 day period; and(b) diligently pursues such remedy to completion. If Hotel fails to diligently pursue such remedy, SRC may elect to seek remedies for default.

Hotel shall mean RI Speedway, LLC.

**EDA** shall mean that certain Economic Development Agreement entered into by and between Rebar and the SRC on November 2, 2018 and amended thereto on December 19, 2019.

Excess Real Estate Taxes shall mean any property taxes in excess of One Hundred Forty Thousand Dollar (\$140,000) annually, or in the event the Real Estate Taxes are One Hundred Forty Thousand Dollar (\$140,000) or more annually, an increase of more than 3% of the prior year's Real Estate Taxes.

Event of Default shall have the meaning set forth in Subsection 6(a).

Force Majeure Event shall mean: (a) acts of God; (b) flood, fire, earthquake, other potential disaster(s) or catastrophe(s) such as epidemics, or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot or other civil unrest; (d) government order, law, or actions; (e) embargoes or blockades in effect on or after the date of this agreement; (f) national or regional emergency; and (g) strikes, labor stoppages or slowdowns, or other industrial disturbances; (h) telecommunication breakdowns, power outages or shortages, lack of warehouse or storage space, inadequate transportation services, or inability or delay in obtaining supplies of adequate or suitable materials; and (i) other events beyond the control of Hotel.

Laws shall mean all applicable laws, statutes, and/or ordinances, and any applicable governmental rules, regulations, guidelines, orders, and/or decrees.

Hotel Project Site shall mean the site described on Exhibit B to this Agreement.

Payment shall mean the biannual payment of Real Estate Taxes.

Real Estate Taxes shall mean all ad valorem real estate taxes that are or would be levied, imposed, or charged on, against, for, or with respect to, all or a portion of the Hotel Project Site by or for all Taxing Authorities, assuming application of the Applicable Rate to the Assessed Value without any credits, exemptions, deductions, or other reductions. All taxes, assessments, levies, impositions, duties, imposts, fees, contributions, and charges of any nature that, in whole or in part, are or would be levied, imposed, or charged in substitution or replacement for or of ad valorem real estate taxes shall be deemed to be "Real Estate Taxes" for all purposes, notwithstanding the denomination or characterization of such taxes, assessments, levies, impositions, duties, imposts, fees, contributions, or charges.

Tax Expert shall mean a party with expertise in the calculation of real estate taxes (including, without limitation, the determination of assessed value and the application of the proper tax rate to the assessed value), which party shall not be an affiliate of, or affiliated with Hotel or the SRC.

Taxing Authority shall mean the State of Indiana or any county, township, school corporation, library district, special district, municipality, or other governmental agency or authority in or of the State of Indiana, including, without limitation and when applicable, the Town.

Term shall mean the period set forth in Section 2.

- 2. Term. The "Term" of this Agreement shall: (a) commence on the Commencement Date; and (b) expire upon the sooner of (i) two years after when the debt service on the Bonds has been fully and indefeasibly paid in full or (ii) October 4, 2048 (the "Termination Date").
- 3. Payments. Beginning in 2025, Hotel shall make the Payments. Hotel and its successors in title to the Hotel Project Site shall pay all Payments before the tax bills are delinquent. Except as provided herein, nothing in this Agreement shall be deemed to release Hotel from the obligation to pay any Payment or assessments on the Real Estate regardless of when payable or assessed.
- 4. Appeals. Unless there are Excess Real Estate Taxes, during the Term, Hotel shall not challenge or appeal the: (A) Assessed Value or (B) Applicable Rate. In the event of a breach of this Subsection, the SRC in addition to all other rights and remedies set forth in Section 6, shall have the right to specific performance against Hotel, including, without limitation, withdrawal and/or unwinding of any challenge, appeal, or other action, and Hotel's stipulation of the Assessed Value so that Hotel is no longer in breach of this Subsection.
- 5. Construction Timeline. Subject to a failure or delay caused by or resulting from acts beyond Hotel's control, including without limitation, a Force Majeure Event, Hotel agrees to: (i) commence construction on the Hotel Project Site within three (3) years of the date on which Hotel takes fee simple title to the Hotel Project Site and (ii) complete construction two (2) years from the commencement of the construction on the Hotel Project Site. Hotel shall give notice within thirty (30) days of the Force Majeure Event, stating the period of time the occurrence is expected to continue. Hotel shall use diligent efforts to end the failure or delay and ensure the effects of such Force Majeure Event are minimized.

#### 6. Defaults and Remedies.

- (a) Events of Default. It shall be an "Event of Default" if any party fails to perform or observe any term or condition of this Agreement to be performed or observed by if such failure is not cured within the Cure Period.
- (b) Remedies. Whenever an Event of Default occurs, the non-defaulting party may take whatever actions at law or in equity are necessary or appropriate to: (i) collect any payments due under this Agreement; (ii) protect its rights under this Agreement; (iii) enforce the performance or observance by the defaulting party of any term or condition of this Agreement (including, without limitation, the right to specifically enforce any such term or condition); (iv) cure, for the account of the defaulting party, any failure of Hotel to perform or observe a material term or condition of this Agreement to be performed or observed by it; (v) if the Event of Default is due to Hotel's default pursuant to Section 5 of this Agreement, Hotel shall have no right to appeal the Real Estate Taxes of the Hotel Project Site unless and until such Event of Default has been cured.
  - (c) As collateral security for the prompt and complete payment and performance in full when due of the Real Estate Taxes set out in Section 2 hereto, Hotel hereby pledges and grants to SRC a continuing first priority security interest in and lien upon all of Hotel's rights, title and interests in, on and to the Hotel Project Site to the extent and the same as a real property tax lien pursuant to Ind. Code§ 6-1.1-22-13. The lien and security interest securing Hotel's obligation to make the Real Estate Taxes automatically attaches to the Hotel Project Site on the date of this Agreement to the extent and the same as a real property tax lien pursuant to Ind. Code§ 6-1.1-22-13 and is binding upon Hotel and its successor in title to the Hotel Project Site to the extent and the same as a real property tax lien pursuant to Ind. Code§ 6-1.1-22-13; has a priority over all other liens to the extent and the same as a real property tax lien pursuant to Ind. Code§ 6-1.1-22-13.
- 7. **Termination.** This Agreement shall terminate from and after the date that is the earliest to occur of: (i) the date of defeasance of the Bonds; (ii) when the debt service on the Bonds is fully and indefeasibly paid in full; or (iii) the Termination Date. Notwithstanding the definition of Bonds, as set forth in the Recitals hereto, if: (a) there is a restructuring of the Bonds; and/or (b) the Bonds are repaid, refunded, redeemed, defeased, refinanced, and/or "taken out" in full and replaced with a new financing, then the restructured Bonds and/or the new financing shall constitute the

"Bonds" for purposes of this Agreement so long as such Bonds do not extend the Bonds' initial maturity date.

- **8. Indemnification.** Each party shall indemnify and hold harmless the other party from and against any and all claims, damages, losses, and expenses (including, without limitation, attorneys' fees) arising from or connected with the breach by such party of any term or condition of this Agreement. The foregoing indemnification obligations shall survive the expiration of the Term.
- 9. Binding Effect. This Agreement shall: (a) run with the Hotel Project Site; (b) bind the Hotel and each successor Hotel of all or any portion of the Hotel Project Site; and (c) inure to the benefit of the SRC.
- 10. Notice of Appeal. Notwithstanding any other provision of this Agreement, the Hotel shall provide the SRC with written notice of any intended challenge or appeal of the Applicable Rate or the Assessed Value throughout the Term.
- Notice. Any notice required or permitted to be given by any party to this Agreement shall be in writing, and 11. shall be given (and deemed to have been given) when: (i) delivered in person to the other party; (ii) three (3) days after being sent by U.S. Certified Mail, Return Receipt Requested; or (iii) the following business day after being sent by national overnight delivery service, with confirmation of receipt, addressed as follows: to Town at 5300 Crawfordsville Road, Speedway, IN 46224, Attn: Redevelopment Commission, with copies to: ; and to Hotel to Rebar with copies to: Eric M. Douthit, Church Church Hittle + Antrim, 2 North 9th Street, at Noblesville, Indiana 46060 Any party may change its address for notice from time to time by delivering notice to the other party as provided above.
- 12. Authority. Each undersigned person executing this Agreement on behalf of the SRC, Rebar and Hotel represents and certifies that: (a) they have been empowered and authorized by all necessary action of the SRC and Hotel, respectively, to execute and deliver this Agreement; (b) they have full capacity, power, and authority to enter into and carry out this Agreement; and (c) the execution, delivery, and performance of this Agreement duly have been authorized by the SRC, Rebar and Hotel, respectively.
- Miscellaneous. This Agreement: (a) may be executed in separate counterparts, each of which shall be an original, but all of which together shall constitute a single instrument; (b) shall be governed by, and construed in accordance with, the laws of the State of Indiana; (c) may be modified only by a written agreement signed by both the SRC and Hotel; and (d) shall be recorded by Hotel at its cost. The invalidity, illegality, or unenforceability of any one or more of the terms and conditions of this Agreement shall not affect the validity, legality, or enforceability of the remaining terms and conditions hereof. All Exhibits referenced in this Agreement are attached hereto and incorporated herein by reference. All proceedings arising in connection with this Agreement shall be tried and litigated only in the state courts in Hamilton County, Indiana, or the federal courts with venue that includes Marion County, Indiana. Hotel waives, to the extent permitted under applicable law: (a) the right to a trial by jury; and (b) any right Hotel may have to: (i) assert the doctrine of "forum non conveniens"; or (ii) object to venue.
- **14. Recordation**. This Agreement shall be recorded by Hotel at its cost upon closing of its purchase of the Hotel Project Site.
